URGENT INFORMATION: Important Update on Construction and School Day Changes for Wednesday, Thursday and Friday of THIS WEEK:

Sierra House Families and Staff:

First and foremost, in further response to parent concerns for student safety, the District wants to reassure you that all safety protocols outlined in yesterday's bulletin (and attached again here) are being followed by district staff and Belfor construction staff, with fidelity, and with the understanding of the sensitive nature of construction workers being in the vicinity of students. Again, separation of the construction zones and learning spaces is in place. There is no interaction between construction workers and students, period. Workers are not using student bathrooms, contrary to DISPARAGING RUMORS. There was not a construction fire yesterday, contrary to DISPARAGING RUMORS.

On Friday, September 6, the district obtained DSA (Division of State Architect with construction authority for inspection and approval to occupy) approval to occupy specific areas of the school site deemed safe for occupancy including the kitchen, lunch room (½ of the MPR), four classrooms in the upper pod, the lower pod, the office, restrooms, and the portable classrooms. Late in the day on Friday, the Lake Valley Fire Chief insisted that the upper pod not be reoccupied until the four remaining classrooms were completed. The district complied and moved those students to Al Tahoe school site as of Monday, Sept. 9. A Notification of Occupancy #DSA 6PI 211 was filed yesterday.

Upon occupation of the school, the responsibility of fire and safety was transferred from DSA to Lake Valley Fire. Yesterday, in the construction area in the nurse's office, smoke was caused due to the grinding of a pipe, triggering the fire alarm. There was NO FIRE, however, upon further inspection, Lake Valley Fire Chief Tim Alamada, determined the following:

**MPR:** Half of the MPR is blocked off for construction. Because the MPR accordian wall is not fireproof, and for precautionary measures, the chief requests that the students receive their lunch by delivery to their classrooms.

**Lower Pod:** Chief Alameda is requesting to complete the construction of a fire wall in the Speech room, adjacent to the nurse room and lower pod. For precautionary measures he is requesting that the lower pod, including Kindergarten, Special Ed, and 1st grade classes, be relocated until the firewall is constructed.

**Portables:** Chief Alameda approved the occupancy of the free-standing portable classrooms - 4th and 5th grade classes, and Ms. Pilsubry's 2nd grade class. These students may remain on campus.

**Additional Fencing:** Temporary chain link fencing is replacing the orange construction fencing and caution tape to address public concerns.

In response to Chief Alameda's request, beginning tomorrow, September 11, 2019, all K-5 students will be bussed to Al Tahoe for breakfast and morning recess.

On Friday, September 13, Lake Valley Fire will inspect the firewall installation adjacent to the lower pod, and if approved, will allow students to reoccupy the lower pod permanently. They will additionally inspect the upper pod which is expected to be approved, so that all students will be back to the campus on Monday, September 16. Access to the upper pod will continue to be from the outside doorways until all construction is complete. Belfor is in the process of removing Conex boxes on campus over the next two weeks.

ALL STUDENTS - BEGINNING TOMORROW, SEPTEMBER 11: All students will be dropped and/or bussed to the Al Tahoe Campus, including those students in the portable classrooms. All students will eat breakfast and have morning recess at the Al Tahoe campus.

SIERRA HOUSE PORTABLE CLASSROOM STUDENTS ONLY: 4th and 5th grade classes, and Ms. Pillsbury's 2nd grade class will then be bussed back to Sierra House for the school day. At the end of the day ALL BUSSERS, SIBLINGS OF STUDENTS AT THE AL TAHOE SITE, AND BOYS & GIRLS CLUB STUDENTS will be bussed back to the Al Tahoe campus. ALL OTHER STUDENTS MAY REMAIN AT SIERRA HOUSE FOR PARENT PICK UP.

MINIMUM DAY ON THURSDAY: All elementary schools have a minimum day on Thursday for Back to School Night. While Sierra House school will not hold its Back to School night on Thursday (TBD after construction is completed) it will still have a minimum day. School will be out at 12:50 PM. Portable Classroom students at Sierra House who are bus riders and B&G Club students will depart Sierra House at 12:50 PM and go to Al Tahoe. At 1:00 PM, bus riders going home will depart from Al Tahoe and B&G Club students will remain at B&G Club. Portable Classroom student pickups may be picked up at Sierra House at 12:50 PM.

IN SUMMARY: All K-3 and SDC students, with the exception of Ms. Pillsbury's 2nd grade will remain at Al Tahoe during the school days Wednesday, Sept. 11 through Friday, Sept. 13. Bussing to and from, and pick up to and from, for these students will take place at the Al Tahoe site.

If a parent has any issue or concern and wants to request independent study until the completion of construction, please see Shandi Ashmore in the front office at Sierra House school. The overall target date for completion of the entire school is Monday, September 23, 2019.

Thank you for your continued support and positivity as we work together toward the close of the reconstruction project.

Hello Sierra House families,

Members of the Board of Education have been approached by parents asking various questions about the construction at Sierra House. We hope the following Questions/Answers will address some of your concerns:

#### Question: Why has the construction taken so long to complete?

Answer: All public school construction projects are under the authority of the CA Division of State

Architect (DSA). The process of evaluating, planning, tearing down, rebuilding, and inspecting is time consuming. In this case the school was required to bring the campus to ADA (Americans with Disabilities Act) compliance in addition to the required structural repair and cleaning work. DSA gave the district approval to start work in mid-June. The district's liability insurance company required the district to use Belfor's services. The District did not choose the construction company and had very little say in the use of outside, or local, vendors. Belfor's main office is out of Reno and most of the

workers commute every day.

#### Question: When will the construction be completed?

Answer: At this time the target date for completion of the remaining four classrooms in the

upper pod is Wednesday, September 11. The overall target date for completion of the entire school is Monday, September 23, 2019. These are estimates. The original target date was August 26. Parents and staff expressed their wishes to move back into the Sierra House campus at the beginning of the school year, and to not have to be relocated again to Al Tahoe and South Tahoe Middle School. This was the district's goal since receiving DSA approval in June, however, with typical construction delays, the

school is just now able to be occupied in limited spaces.

Question: Why were students allowed to go back to school with construction work still

occurring?

Answer: It is not unusual for school construction to take place while students are in school. Over

the last fifteen years at LTUSD, Dr. Tarwater has overseen \$100 million in construction projects over a period of five years, at South Tahoe High School, Bijou Community School, South Tahoe Middle School, during the school year. Districts all over California frequently do construction work during the school year. The US Department of Education funded a publication titled, "A Principal's Guide to On-Site School Construction," which LTUSD has used as a guide throughout this process.

Question: What precautions are being taken to safeguard students while construction is

occurring during school hours?

Answer: Please see the attached Protocols for Safe Operation of Sierra House School which

addresses Separation of Construction and Instructional Spaces; Communications; Fire Alarm Coverage and Fire Watch; and Security Protocols. In addition, Belfor's protocols

regarding interacting with staff and students is to remain inside the construction zoned areas – any movement of vehicles or personnel through non-construction zones is coordinated with front office staff by radio. Movement is postponed if during or close to a passing period or other time where students are being moved outside the buildings. Belfor handles background checking of its employees and it is the responsibility of Belfor's DOJ-cleared Supervisor, to oversee these protocols and ensure there is not interaction with staff and students.

#### Question: Who is responsible for construction oversight and occupancy?

Answer: DSA's involvement with Fire and Life Safety review of public s

DSA's involvement with Fire and Life Safety review of public schools derives from Govt. Code Section 14963 which states, "The duties and functions formerly conducted by the State Fire Marshal that relate to construction, school, plan checking, and construction inspection are hereby transferred to the Office of the State Architect."

The qualifications for the personnel reviewing fire and life safety aspects of school construction projects at DSA are the same as the qualifications required by the Office of the State Fire Marshal (OSFM).

Notification of Occupancy #DSA 6PI 211 filed today, documents the school site areas being occupied and in compliance, and identifies those areas still under construction, and therefore not compliant. In addition, the newly installed fire alarm and control devices bring the school to current standards which is a significant improvement over the old system. Please note, however, that the fire alarm system may be triggered over the next couple of weeks due to construction.

# **Protocols for Safe Operation of Sierra House School**

# Separation of construction and instructional spaces

- 1. All construction areas are off limits to students and staff. The construction zones consist of:
  - Areas roped off with snow fence or caution tape
  - The following portions of the main school building: Upper pod, corridor to upper pod, main corridor from boiler room to midpoint near corridor to upper pod, special room, PE room and 1/3 of MPR.
- 2. Students should be chaperoned to soccer field and play structures for play times.
- 3. Kindergarten playground will be free of construction activities and may operate normally.
- 4. Path of travel for students in portables 1-6 consists of travelling across the fronts of the portables to the rear (P6) in order to access the playground. There is no access to the main building from near P1.
- 5. Path of travel for students in P7 is across the front of P1-6, as above. There is no access to the main building from near P1.
- 6. Students in R5-8 shall be escorted across the blacktop to the play structures and soccer field for play time.
- 7. The rear of the lobby may be used to access lower playground. Snow fencing is set up to keep students away from the special room and the exterior to rooms R9-11. Students will be released from the MPR at 8:55 to the lower blacktop area where monitors will direct them to the play structures and soccer field for the 15 minute period of play before school starts at 9:10 AM. Students will then line up for their teachers and be led to their classrooms via approved paths of travel
- 8. Any movement of construction vehicles or personnel through non-construction zones must be coordinated with front office staff. Belfor will call the front office on the radio and inform staff of the impending movement. A staff member will be dispatched to escort the vehicle or personnel from one zone to another. Movement will be postponed if during or close to a passing period or other time where students are being moved outside buildings.

#### **Communications**

- 1. Phones are up in Lower Pod and Portables. The phones will be used to communicate any construction activities that may impact paths of travel. They may also be used for All-Call communications/announcements as they were before the fire.
- 2. Radios will be distributed to all classrooms. Radios will be used as backup communications for phones and for communications to staff on playground duty. Radios shall also be used between Fire Watch and front office. All staff should keep radios on them when not in their classroom.

# Fire Alarm coverage and Fire Watch

1. The Fire Alarm is complete with the exception of the beam detectors in the MPR. The fire alarm devices in the occupied spaces are functional and are being monitored. Any dust or smoke

generated in the occupied classrooms, offices, corridors, restrooms or the kitchen will trigger the fire alarm. The smoke monitoring devices in the construction zone will remain covered with dust caps until the area is deemed complete. For this reason (and the MPR), a Fire Watch protocol will be in effect. Additional portions of the building will be brought on line as construction activities are completed in each area.

- 2. The new fire alarm system now includes horns and strobes (flashing lights) in every space in the building. There will likely be a fire drill in the first few days back. Expect bright flickering lights, siren sounds and a recorded voice announcement instructing occupants to evacuate.
- 3. **Note: Permanent change to fire alarm/drill protocol.** Assembly area has been moved off of blacktop onto the soccer field. The blacktop must remain clear for the emergency response vehicles. All other fire alarm/drill protocols and evacuation routes will remain the same as from before the fire.
- 4. Fire Watch: A dedicated LTUSD staff member will be assigned to a standard fire watch for the construction zones and the MPR. During breakfast and lunchtimes, when large numbers of students are present in the MPR, a second LTUSD staff member will be assigned to focus on that area, and the primary Fire Watch person will closely monitor the closed portion of the MRP and the stage area. The Fire Watch patrol shall be executed every hour, and any violations, corrections, observations or comments shall be recorded in the Fire Watch log. The log shall be made available to the Fire Marshal upon request. A separate log shall be kept for the open portion of the MPR. All members of the Fire Watch shall carry radios during occupied hours at the school. After hours fire watch shall carry a cell phone to call 911 should any incidents be detected when they are alone on site. All Fire Watch personnel will be familiarized with Fire Extinguisher locations and the Pull Station at the front door.
- 5. Fire Extinguishers: Please do not move any fire extinguishers from their hangers unless it is to use them. Note the new fire extinguishers in the library in the lower pod and memorize their locations if they are closest to your classroom. Fire extinguishers may be placed on the floor spaced throughout the construction zone and in the MPR with signage posted above specifically for the Fire Watch. Never move these fire extinguishers without coordinating with Fire Watch.
- 6. Vehicle gates and emergency services ingress: LTUSD staff will be assigned to respond to the two vehicle gates in the event of a fire alarm or other emergency (medical, etc). They will then unlock and open the gates as emergency vehicles arrive in case they need to drive to areas within the site. Construction zone delineation near fire lanes is made with caution tape so they can drive through it in case construction personnel cannot get the tape down before they arrive. No fire lanes shall be obstructed by construction materials, vehicles of any kind, assemblies of students or any other obstacles (garbage cans, debris, tools, furniture, boxes, etc.). Fire Watch will walk fire lanes as part of patrol to ensure the path of travel is being kept open.

# **Security Protocols**

- 1. Keep vehicle gates and man gates closed and locked when school is in session (standard operating procedure from before fire).
- 2. Lockdown procedure remains the same for classrooms, offices and main entrances. Lock doors, draw blinds, turn off lights, and be quiet.

# Attention All 3<sup>rd</sup> Grade Parents and Parents of Vivian Rider's 2<sup>nd</sup> Grade Class:

There have been safety concerns raised about construction continuing in the upper pod while students occupy the adjacent classrooms. As you know, four classrooms are completed, and four are still under construction. While it is not uncommon to occupy a school during construction, the district has decided to relocate the four classrooms  $(3-3^{rd} \text{ grade})$  and  $(3-3^{rd} \text{ grade})$  offsite to the Al Tahoe campus until construction is completed. The district feels this is in the best interest of student safety and will also allow an expedited construction process for the four remaining rooms. **Those students being relocated will still arrive and depart from the Sierra House campus**. Students will be bussed after breakfast to the Al Tahoe campus. At the end of the school day students will be bussed back to Sierra House where they can be picked up by parents or depart on buses.

On Monday morning  $2^{nd}$  and  $3^{rd}$  grade teachers will be on the grass in front of the school to greet parents and students, make sure permission slips are signed, and find out how their students will go home each day (i.e. bus or pick up).

All other classrooms in the portables and lower pod will be occupied and school will open on Monday as planned. Construction will continue in the upper pod as planned and the *estimated* completion date for the four remaining classrooms is September 13, 2019.

All students in the third grade are going on full-day field trips next week on Tuesday and Wednesday.

Upon arrival on Monday you will see construction workers and vehicles as they continue to complete the four classrooms in the upper pod. **The construction area will be sealed off from staff and students.** 

The district appreciates the extremely hard work of the many people involved in getting Sierra House up and running. Although this slight setback is inconvenient, we will continue to work together, be proactive, and look forward to the coming weeks when Sierra House School is whole again. Thank you for your continued patience and support of our school.

On June 12<sup>th</sup> the district was granted approval by the DSA (California Division of State Architect) to begin the restoration process at Sierra House Elementary School. The school had been demolished down to the studs in 70% of the spaces in order to remove all smoke damaged building materials. The construction team is working very hard to complete all work before the scheduled first day of school (August 26<sup>th</sup>.) As we get closer to that target date, and as more information becomes available, we will continue to provide updates. Additionally, as promised, the District will conduct air quality testing prior to the reoccupation of the school.

Since the construction phase began on June 13<sup>th</sup>, the following milestones have been achieved:

- 90% of all ductwork and heating units in the affected areas have been rebuilt or replaced.
- 90% of walls and roofs have been re-insulated to much higher R-values than the building originally had.
- 90% of walls in corridors, MPR, PE room, and upper pod have received new drywall.
- The Staff restrooms had the floors demolished and have been reconfigured to meet new ADA standards. The new walls were erected, insulated and drywalled. The wall tile is being installed now.
- The front walkways and sidewalks were demolished and re-poured to be brought up to modern ADA code.
- The modern Fire Alarm System (ADA compliant) is more than 50% installed.

LTUSD would like to extend our sincere appreciation to Belfor, Artifex Homes, Gardner Mechanical, Sierra Valley Electric, Far West Insulation, BEI, Ron Fuller, Custom Concrete, and all of the LTUSD staff that have been working hard this summer to get our school open again. We thank you for your patience.









The insulation and HVAC subs have already begun working, and additional subs are expected next week to try to make these targets a reality. The Sierra House DSA approval is almost complete. We received final approval on ADA, structural and Fire Life Safety for all aspects of the project except Fire Alarm. The DSA asked for some additional modifications to the fire alarm drawings which are taking longer than expected, but are anticipated to arrive at the architect's today (6/7/19). The architect expects to have full DSA approval by Monday 6/10/19, and the contractors have already begun to mobilize multiple crews in anticipation of a full court press to get the building done by early August. At this time there is not a set date for return to Sierra House. We may be looking at spending the rest of the year at Al Tahoe, especially for the 2nd and 3rd grade classrooms. Our plan is to settle in at South Tahoe Middle School and Al Tahoe and make the most of where we are.

Here is a brief update on the fire recovery effort:

- · Upper pod abatement is almost complete.
- MPR demo to start soon.
- PE room is being cleaned out right now so they can drop ceiling and determine if walls can stay or must go-

Admin has been cleaned out and they are getting ready to drop the ceiling and will determine if walls can stay or must go.

- · Electricians have been in to bid on electrical room equipment removal and restoration.
- · Encapsulation of Portables HVAC ducting and coils is complete.
- · Architect visited to finalize scope (as best we can at this point). DSA appointment has been pushed back due to rolling reading room structural into scope. This will not delay reconstruction as he has already specified the replacement products (for Admin and MPR) and Belfor can order them.
- · Architect would like to propose a different tile scheme for the restoration of the restrooms. It will be more similar to the HS restrooms
- · Conference call with insurance, architect, DSA inspector to start penciling out a schedule. Still need to know if PE room and Admin walls will stay or go.
- · Asbestos mastic was found under the walk-off mats at the entry and exit of main lobby. Will need to be abated.
- · Belfor is looking for the most efficient ways to demo/access areas around the burnt space to minimize invasive demolition that will delay construction.
- · Architect has discussed with the DSA a method of reinforcing the burnt ceiling rafters to minimize invasive, time intensive reconstruction of the burnt area. We should have approval within 2 weeks for the carpenters to begin repairing that space.

As far as communication, since Remind is no longer working with Verizon customers, it is more important than ever that all parents are signed up with correct Aeries account information so that school and classroom communications can go through this platform. All teachers have access to Aeries Communication and all families receiving this email are already linked to this platform.

This is an important information update regarding school on Monday. In consideration of traffic congestion issues, we have made some minor adjustments to the school schedule, so please read this bulletin carefully:

To help facilitate a smoother parent pick-up and drop off, and bus transportation system, school hours will be reverted back to last year's schedule of 9:10-3:20. <u>This will not affect bus stop pick-up/drop-off times.</u>

# **Parent Drop-off:**

All students who <u>eat breakfast</u> at school should be dropped of at Al Tahoe at 8:30 for breakfast and recess. Students in <u>grades K-3 who do not eat breakfast</u> should be dropped of at Al Tahoe between 8:50 - 9:10. Students in <u>grades 4-5 who do not eat breakfast</u> should be dropped of at STMS between 8:50 and 9:10 AM at the library wing entrance to the school, adjacent to the bus garage. Enter the parking lot roadway entrance near the track & field, on the east side of the school, off Al Tahoe Blvd., **or** drop off in front of the school on the south side of the school. Utilizing these two entrances will reduce traffic congestion.

If you are parking and walking in to visit your child's classroom at STMS, please park near the tennis courts on the north side of the campus and walk through the main entrance, check-in, and follow the signs to the library wing. We will have several people out to greet students and parents and show them to their classrooms.

#### **Bus Drop-off:**

All bus riders will arrive at Al Tahoe at 8:35 AM for breakfast and/or recess. Grades 4-5 will be transported by bus to STMS at 9:00 AM.

#### Parent Pick-up:

After school pick ups for grades K-3 will begin at Al Tahoe at 3:10. If you have a 4-5 sibling, continue on to STMS for a 3:20 pickup.

After school pick ups for grades 4-5 at STMS will begin at 3:20 in the front of the school. You may line up in the traffic circle or you may park near the tennis courts to walk up and pick up your child. Dr. Tarwater will be there to help direct you through the traffic circle. Students will be escorted to the front of the school by campus security and teachers.

#### **Bus Pick-up:**

4th - 5th bussers will be picked up at STMS outside of the library at 3:20. Teachers and campus security will be present to assist with loading.

K-3 Students will be picked up at Al Tahoe at 3:28.

4-5 Boys & Girls Club students will get off the bus at 3:28 at Al Tahoe.

<u>Special Needs bussing:</u> Drop off at Al Tahoe: #32 will arrive and drop off at 9:05 (including 2 wheelchair students) Take Home Bus #34 will load at 3:00 from the bus circle and depart by 3:10. (including 2 wheelchair students)

Sierra House Recovery Process
January 9, 2019

While Sierra House Elementary School is under repair from the fire and subsequent smoke damage, we are working diligently to maximize learning and continue the integrity of our high quality academic programs. As repair work progressed over the winter break, it became clear the timeline is longer than anticipated. We are looking to utilize many of our district resources to accommodate a full day schedule for all of our students until all work is completed. We are excited to be able to run Sierra House classes from 9:00 AM until 3:10 PM for all students beginning Monday, January 14th. Kindergarten, first, second, third grades and our SDC classes will all be held at the Al Tahoe campus. Fourth and fifth grade classes will be held on the campus of South Tahoe Middle School (STMS). STMS principal John Simons has worked closely with the district and Sierra House to ensure a smooth transition for our students and staff. The district has set up a "school within a school"; meaning we are able to maintain the separation of the elementary school from the middle school. Our Sierra House 4th and 5th grade classes will be held in six classrooms in the STMS library/science wing. As the former assistant principal at STMS and a teacher of 25 years at the site, I am very confident that our Sierra House students will have a quality learning environment on this campus.

# Each paragraph below will address a different logistical area for the transition of our 4th and 5th grade students.

#### 4th/5th Schedule:

Sierra House students who are bussed to school will be dropped off at the Al Tahoe site in time for breakfast and morning recess with all the other Sierra House students. They will then be escorted to STMS in order to start class at 9:00 AM. All students will be in self-contained classrooms. Recess will be held outside (weather permitting) while STMS students are in class. If the weather is inclement, they will have indoor recess in their classroom with their teacher. There will be a seperate lunch for our 4th and 5th graders.

STMS begins at 7:45 AM and ends at 1:55 PM (except for Wednesdays when they dismiss at 12:55 for staff collaboration days). Our students will not be on campus when STMS students arrive and they will be in class when STMS students depart. Sierra House students will not be allowed in the halls during passing periods.

## Kindergarten-3rd schedules

All kindergarten, first, second and third graders and all SDC students will attend school on the Al Tahoe site from 9:00 until 3:10.

\*\*\*Sierra House and STMS schedules are attached to this document.

#### Transportation:

All Sierra House students will be dropped off at the Al Tahoe campus for breakfast and morning recess. They will then be transported to STMS to arrive at class by 9:00. If you are dropping off your 4th or 5th grade student, you may drop them off past the entrance to the track between 8:50 and 9:00. We will have STMS security meet the students at the gate and students will go directly to their classroom. After 9:10, the gate will be locked and students will need to be dropped off at the front entrance and check in with the office staff to be escorted to their classroom.

After school, busses will pick up Kindergarten - 3rd grade students at Al Tahoe at 3:05 and proceed to STMS to pick up 4th and 5th graders at 3:10. The busses will line up parallel to the STMS wing where our classes are located. All busses will depart from STMS by 3:20.

Parent pick ups for kindergarten through third grade will remain at the Al Tahoe site. Parent pick ups of fourth and fifth graders will be at the front of STMS from 3:10-3:20.

# Nursing:

Karen Tucker is the wonderful full time nurse at STMS. She will be available for any student on the STMS campus. She is also there to deliver any medications required by 4th and 5th grade students. She and Esther King communicate closely and will continue to do so as we run this "school within a school" model. Esther King will be full time on the Al Tahoe campus.

#### Early Pickup:

If your student has a doctor appointment or other reason to leave campus during the school day, they will be paged and brought to the front office for pick-up.

# **Discipline and Administrative Support:**

I will continue to work as principal for the 4th and 5th graders located on the STMS campus. All questions and concerns should be directed to me via the Sierra House phone (530) 318-1517. I was the assistant principal at STMS for 4 years and spent the majority of my teaching career there as well. I understand the school and can answer any questions you may have.

#### Security:

STMS campus security monitor, Ryan Wallace, will be stationed in the 4th/5th grade hall of STMS while we are on campus. He will have a desk located directly across from the bathrooms located in this hallway. He will be located here to ease student and parent concerns. His job is to make sure there are no negative interactions between any students in the hallways or bathrooms. All Sierra House students will be in class during STMS passing periods. Miguel Tapia is a second campus security assistant at STMS who will monitor arrival and departure of busses and lunch time.

#### Kid Zone:

Kid Zone will continue to operate from the Al Tahoe campus for all students K-5. Kid Zone runs from 7:30-8:30 every morning.

#### Parent Open House and Meeting:

All parents are invited to come to class with their student and check out the classrooms at STMS at 9:00 on Monday, January 14th. We will have a parent orientation meeting at 9:20 in the STMS library in order to answer any questions. If you cannot make that meeting, we will hold a second meeting Monday evening at 5:30 p.m. in the STMS library.

As always, I thank you for your flexibility, patience, and understanding as we have worked through this recovery process. Every one of us looks forward to returning to our Sierra House campus. The beauty of Sierra House is that WE are all Sierra House. We are not defined by a building, we are defined by our excellent teachers, our strong support staff, our families and our students. Together we will make the most

of each day, advance our children's academic, physical, and social well being as we bring Caring, Organization, Responsibility, and Empowerment to the forefront of our educational process.

Thank you for your support and we look forward to getting settled into our schedules and routines.

Hello Sierra House Families,

This is the latest update regarding the Sierra House recovery plan. Yesterday the district was notified by Belfor that we need to look at a longer term plan before Sierra House can be reopened. The scope of work has expanded now to include the removal of insulation inside the walls in the multi-purpose room and replacement of the ceiling in the administrative office. At this point, there are no specific dates tied to reopening Sierra House. This was not the news we were hoping to hear, but it is the reality of our situation.

In consideration of the indeterminate amount of time for the reopening of Sierra House, it will be most beneficial to the students and families to return to full instructional days. Therefore, the district will establish a "school within a school" model at South Tahoe Middle School for 4th and 5th graders in their own wing near the library. All 4th and 5th graders will be relocated to this wing in order to provide full-day classrooms and instruction, between the two campuses, for all grade levels. We are working on the logistics and will send a detailed letter home tomorrow.

All Sierra House students will return to the 9:00-3:10 school day starting on Monday, January, 14th. Kindergarten through third grade will continue to be on the Al Tahoe campus, and 4th/5th grade at STMS. I will continue to provide leadership and support at both campuses. More information will be provided on Wednesday, January 9, 2018.

There have been questions about lead in the water and the presence of asbestos in the school. The drinking fountain that tested positive for lead was removed from use in August of 2017. We will be providing 4 water bottle filling stations for all students. The other two locations that tested above the reportable limit are in the kitchen, which we will not be using to prepare food for our students.

The Al Tahoe school is regularly tested for friable asbestos on a three-year cycle to determine that all sources of asbestos are stable and contained. The AHERA three year testing was performed within the last 18 months. All sites, including Al Tahoe, tested safe.

At this time Belfor continues with remediation protocol per the report dated November 28, 2018. Additionally they are preparing specific deep-cleaning and reconstruction plans for the next phase. This includes scheduling, man power allocation, and material acquisition. Work will begin on Wednesday December 12th and will include the replacement of ceiling tiles and other porous materials; deep cleaning within the attic space; and restoration of the HVAC system and duct work in the source area, hallways, and restrooms. The goal is to complete the remediation and odor abatement prior to January 7th, when students return to school after the winter break.

In order to facilitate this plan in an expeditious manner, we will be moving all students from the upper pod (2nd and 3rd grade) to the Al Tahoe site beginning Wednesday, December 12th. Pick-up and drop-off will remain at Sierra House so as to maintain consistency. As well, buses will continue as regularly scheduled. Breakfast and morning recess will be conducted at Sierra House. Lunch will be served at the Al Tahoe school site. Please see the following daily schedule for grades 2 and 3:

Wednesday December 12th, Thursday, December 13th, and Friday, December 14th: 3rd grade bussed to Al Tahoe from Sierra House after breakfast and morning recess.

2nd grade bussed to Heavenly for skiing.

All students bussed back to Sierra House by 3:00 for 3:10 pick up/ bus ride home.

2nd and 3rd grade students bussed to Al Tahoe from Sierra House after breakfast and morning recess. All students bussed back to Sierra House at 3:00 for 3:10 pick up/ bus ride home.

Wednesday December 19th and Thursday December 20th: 2nd and 3rd grade students bussed to Al Tahoe from Sierra House after breakfast and morning recess. Sierra House had a Site Safety Team meeting this morning and we discussed the fire at length with Tim Alameda, Fire Chief with Lake Valley Fire. We discussed protocols for teachers moving forward with electrical outlets and power cord safety. Tomorrow we are continuing this discussion during our staff meeting with all staff.

Belfor's new project manager, Jim Aguiar did a building walk through to familiarize himself with the school and the prescribed protocols. He will be here every day going forward.

Four surface lift samples (settled dust and debris on flat surfaces), including a worst case from within the affected fire area, came back negative for asbestos. One remaining test is being analyzed, which is a soot sample. We expect results from this sample later this week.

We are holding an "After Action" process meeting on Monday afternoon at 4:00 at the Education Center Board room. If you are interested in participating in this process, please contact Karin Holmes at Sierra House by this Friday.

Results from the air quality test came back negative for harmful substances in the air. School will be open tomorrow (Monday, December 3). Please visit <a href="www.ltusd.org">www.ltusd.org</a> under District-Public Notices for detailed test result information. The following is an email from Nate Seward, Industrial Hygienist:

"VOC sample results came in. As expected, the presence of various Volatile Organic Compounds were detected in each sample, however all concentrations were compared to regulatory OSHA Permissible Exposure Limits (PELs) and/or Time Weighted Averages (TWAs) and found to be well below these regulatory levels. All lab results are provided in PPB (Parts per billion by volume).

Note: Many of the VOCs found are also found in over the counter house hold cleaning products and personal items (i.e. acetone, isopropyl alcohol, etc). These can also be in every day items used in schools, dry erase markers, sharpies, etc. A few of the VOCs found in the samples are also found in citrus odor masking agents and perfumes.....likely those used by Servpro during the deodorization process.

Nevertheless, I have no concerns related to these air sample results which were collected from Upper Pod (all classrooms), Portables 1-7, MPR, hallway and Staff offices and lower pod (all classrooms). Thanks

Sierra House Recovery Process,

This is to inform you that at 3:12 PM today we received notification that a door in the contained burn area tested positive for asbestos. This door was damaged by the fire department when entering the building. As a precautionary measure, air testing is currently under way to ensure continued air quality throughout the school building, with results expected by Sunday.

These results will include both the asbestos and VOC air sample testing.

Asbestos notification posters will be visible on the zippered doorways into the containment area to keep students and staff away from the possibly affected area. These posters must remain in place until the contained area has the subject door removed and the air in all spaces have been cleared. The contained area, which has been completely enclosed since the incident, is under negative air pressure and is being filtered through a HEPA filter. These are standardized procedures required by the EPA and OSHA who have been notified and who will be visiting for inspection and clearance next week.

Sierra House Recovery Process,

This is the second of the daily updates regarding the Sierra House fire restoration process. Today, air scrubbing has continued throughout the building and Air Quality sample canisters that test for detailed Volatile Organic Compound (VOC) were used to collect test samples beginning at 12:00 The results from these tests should be available Sunday night (barring any shipping delays to LA). If the results arrive on time, they will be provided to school staff and parents by 7am Monday morning.

The air quality testing being performed today used the EPA Air Method: Toxic Organics -15 (TO-15) which is designed to look for 74 different VOCs (Target Compounds List or TCL) using analysis by Gas Chromatography/Mass Spectrometry (GCMS). If a spike is detected in the GCMS study that does not match with one of the 74 VOCs in the TCL (unknown compound), the lab will work to identify the air component regardless. The testing is expected to identify any VOC, not just those on the TCL. A full report of all detected VOCs, their levels and acceptable limits (if applicable) will be provided to the district.

Additionally, the following protocols have occured today (11/30):

- 1. The preliminary lead testing (XRF gun) show no lead in paint or tile in any of the affected areas. Final report due later today
- 2. Soot testing is delayed due to recent wildfires in CA. The sample has been sent to the lab. Hopefully we will see results late next week (best case scenario)
- 3. Additional asbestos tests are in the lab and being analyzed as of 11am this morning.
- 4. DSA field personnel will be on site this afternoon to survey building
- 5. The industrial hygienist cleaning protocol draft report has been delivered and is attached to the bulletin.

As far as classrooms, all grade level classrooms are in full use; only our reading intervention classes have been displaced. All reading intervention classes are running on full schedule and meeting in staff work areas. All alarm systems are in good working condition and were serviced and cleared by SIMPLEX on Tuesday, November 13th prior to any students returning to school.

This is the first of the daily updates we will be sending out regarding the fire restoration process. We understand that everyone is anxious to see the results of the cleaning and testing efforts. As of 1pm today (11/29) Premier (Industrial Hygienist) is in the final stages of refining their cleaning protocol, which we hope to send out in tomorrow's update. Belfor (Fire Restoration) has contained all directly affected areas and are running air scrubbers (carbon filters) around the clock in these spaces, as well as the upper pod core space. All remaining spaces in the school will receive proactive air scrubber treatment by Sunday night. Air Quality sample canisters have been ordered for detailed Volatile Organic Compound (VOC) testing tomorrow (Friday 11/30). The results from these tests should be available Sunday night (barring any shipping delays to LA). If the results arrive on time, they will be provided to school staff and parents by 7am Monday morning.

The testing being performed will use EPA Air Method: Toxic Organics -15 (TO-15) which is designed to look for 74 different VOCs (Target Compounds List or TCL) using analysis by Gas Chromatography/Mass Spectrometry (GCMS). If a spike is detected in the GCMS study that does not match with one of the 74 VOCs in the TCL (unknown compound), the lab will work to identify the air component regardless. The testing is expected to identify any VOC, not just those on the TCL. A full report of all detected VOCs, their levels and acceptable limits (if applicable) will be provided to the district.
