Re: Notice of Special Board Meeting July 30 and Good News to Know

Good afternoon LTUSD friends and families,

The district would like to thank you for completing the recent school reopening surveys. Data from the surveys has greatly informed the reopening process and as we move forward with approving a plan, the Superintendent and Board of Education continue to welcome your input. The reopening plan being proposed at a Special Board Meeting tomorrow night will serve as an overarching guide and framework for school sites. Your comments and feedback regarding next school year will continue to assist and inform the process at the site level so please continue to send in your comments to info@ltusd.org. The Special Board of Education meeting is scheduled for 6:00 pm tomorrow, July 30, 2020, to discuss and take action on a final draft of the LTUSD COVID-19 Pandemic Plan for the 20/21 School Year. Here is a link to the full agenda. (Click on 7/30/20 in the right column.) The summary agenda is attached. In accordance with the Executive Stay at Home Order N-29-20 the Boardroom will be closed to members of the public and all public participation will be handled remotely. Please see the Communications from the Public section of the agenda for instructions. Participants and observers may view the meeting via this Zoom link. We hope you can join us.

We've received several questions regarding the <u>Elevated Digital Learning Academy</u> and hope that the following FAQs can help to clarify.

Q:By filling out the Pre-Enrollment form, did I enroll my child in Elevated, and did I lose my current enrollment spot?

A:By completing the Pre-Enrollment form, you did not automatically enroll your child in the school nor did you unenroll your student from the school in which they are currently enrolled for the 20-21 school year. The form was intended only to gauge interest in participation. Enrollment will open in August after the CDE assigns a County-District-School Code, authorizing opening of the school. Enrollment information will be sent to you in August based on the contact information you provided on the form.

Q:What is the difference between the distance learning that will be provided by my child's current school site during the distance learning (campuses closed) phase and the year-long learning provided by Elevated?

A:Elevated is intended for families who are choosing to attend school via online learning only, for the entire school year. It is not a transitional school which one would transfer out after other school campuses reopen to in-person instruction. If district schools reopen under distance learning, all students will receive instruction online until a different school model is implemented, such as traditional, hybrid, etc.

Q:While the other K-8 school sites are providing distance learning, will they provide the same format, structure and curriculum as Elevated?

A:All schools will deliver standards-based instruction. Elevated will use the same curriculum as that of school sites.

Q:Are the required qualifications and experience of the teachers the same? A:Yes. The district is adopting a new learning management system specifically for online learning, called Canvas. All teachers in the district will receive training on the new system and will have the same expectations (by grade level and subject) in delivering standards-based instruction when using Canvas. Grade level collaboration across the district (including Elevated) will ensure a consistent quality and rigor of instruction, however, delivery of instruction offered by Elevated may differ from those instructional modes that are able to be offered in-class (such as labs, group projects, field trips, etc.) Elevated Digital Learning Academy will employ LTUSD teachers who are subject to the same state credentialing requirements and standards as those working at school sites. Elevated is a district school and all teachers (regardless of location) are subject to state credential requirements.

Q: Will the grade levels between all school sites, including Elevated, have the same daily time commitment of the students?

A:Yes, while the district is in the distance learning phase due to COVID-19 safety concerns, equivalent instructional minutes will be consistent by grade level across all schools.

Q:Will the same technology and support be provided to students in each school? A:Yes, all students will receive the same technology and support. For elementary school students:

Q:If, during the 20/21 school year, I want to transfer my student out of Elevated into the elementary school they were to attend during the 20/21 school year, will they be guaranteed enrollment in that school?

A:No. Should school sites reopen during the 20/21 school year for traditional learning, your student is not guaranteed entry into the elementary school they were to attend before enrolling in Elevated. However, they may be admitted into the elementary school if there is room in their grade. This also applies to future school years.

Q:What is the difference between the ILA (Independent Learning Academy) and Elevated Digital Learning Academy?

Q:Are the enrollees eligible to play middle school sports?

A:Yes, however, at this time NIAA and CIF have postponed all fall sports until January 2021.
